It is hereby notified for the information of all the concerned that the BE II/IV I (Old & New), III/IV I, IV/IV I - Semester (Main & Backlogs), 1 year (Old & New), II/IV II, III/IV II - Semester (Backlogs) examinations and Bridge Course I - & II - Semester (Backlogs) and Improvement examinations will be conducted from 30-11-2015. SPECIAL INSTRUCTIONS TO THE PRINCIPALS


- The College login will be closed after the last date.
- The late fee will be levied automatically in case the fee is not Remitted to the O.U. A/c.
- Late fees will be levied, if online EAFs are not submitted on or before due date, even if fees remitted into fund account within due date.
- Principals are requested not to forward/submit the EAF of Not Eligible Candidates. The results of Not Eligible candidates will be cancelled at any stage, if they write the examination.
- The Principals are requested to transfer Consolidated exam fee amount into Registrar, O.U. Exam fee fund A/c No. 52198262033 (SBH, O.U. Branch, IFSC Code "SBHY0020071"). O.U. through NEFT/RTGS only.

Note:-

1. *The Students who were admitted during the Academic year 2007-2008 onwards should submit their examination forms Online through college login. In respect of the Lateral Entry candidates who were admitted in II/IV I - Semester, during the academic year 2015-2016. The colleges have to get the clearance letter from (a) the Director of Academic Audit, O.U., (b) Convener E-CET O.U., (c) PG Admissions and (d) No Dues from the Deputy Registrar Academic Section O.U. and submit the examination forms through college login. The N.R. should be submitted separately in respect of Regular, Lateral entry, Transfer candidates admissions and manual applications separately in duplicate. The hardcopy of the applications submitted through college login be downloaded and submitted to the Examination Branch duly signed by the student and the Principal concerned along with photocopy of qualified examination in respect of Lateral Entry students.*
2. *Clearance certificate from Nodal Officer, Statistical Cell, OU*
3. *The students who were transferred from the University Jurisdiction and other Universities their examinations forms should be submitted separately with the approval of the competent authorities like Commissioner of Tech. Education, Govt. of A.P. and Director Academic Audit, O.U. with allotment of H.T.No.s.*
4. *In respect of the candidates who have completed course requirement having appeared for IV/III semester and completed double the duration of course but did not cross (10) years from the date of admission have to pay an additional amount of Rs.1000/- per subject, semester-wise along with normal semester fee and submit N R in duplicate separately login.*

5. The Principal of Engineering Colleges are requested to collect the examination expenses from each of the lateral entry and transfer students @ Rs.300/- per head and remit the consolidated amount to the Controller of Examinations, OU together with examination fee and application form in terms of OU Circular No. 3872/D/37/93/Acad., dt.15-12-1993.
6. All the Principals are requested to verify the eligibility of the students thoroughly and forward the same to this office for the issue of Hall Ticket. If failed to verify the eligibility of the candidates, the principal will be held responsible for the issue of hall ticket to the non-eligible candidates. Further, it is clarified that the results of such candidates who are not eligible to appear for the examination will be cancelled at any stage.
7. The students who have passed 10+2 from other than Board of Intermediate course, A.P. have to pay Rs. 125/- in addition to examination fee towards Migration fee. The students should submit Migration certificate in original along with the examination form and fee at their respective college principals on 27/10/2015 for onward transmission to the Controller of Examinations for issue of hall tickets.
8. Whenever the syllabus changes, two more examination i.e. one in the following December and the other in the following April shall be conducted according to old syllabus/regulations. Candidates not appearing in these examinations or failing in them shall take the examination subsequently according to the changed syllabus/regulations.
9. **Not to collect the Exam fee from Blind, Physically Disabled, Deaf & Dumb students** as per O.U. Order No. 1555/228/2007-08/Budget-V, dated: 25-03-2008. A Xerox copy of medical Certificate confirming their status as Handicapped (minimum percentage of disability must be of 40% attached to the application forms. Blind, Physically Disabled, Deaf & Dumb students applications forms should be submitted separately along with separate Nominal Roll.
10. **ALL THE PRINCIPALS ARE REQUIRED TO TRANSFER THE FEE AMOUNT THROUGH RTGS/NEFT ONLY FOR CREDIT INTO REGISTRAR OSMANIA UNIVERSITY EXAM FEE FUND A/C NO. 52198262033 (SBH, O.U. BRANCH, IFSCCODE "SBHY0020071").**
11. Any discrepancies with regards to the Candidate data such as Internal marks, Practical, Viva-voce and Projects etc. should be brought to the notice of concerned officials of Examination Branch and obtain the acknowledgement within one month of declaration of results. After one month, queries will not be entertained.
