- 01. The merit list of the candidates who appeared for SVIMSPGSSET entrance test is displayed in the institute website.
- 02. The candidates have to report at 8.30 am. The attendance will be closed at 10.00 am
- 03. The qualified candidates have to report for counseling in person with the following original certificates as detailed in Appendix - II of the prospectus for verification.
- i. Rank card and application abstract.
- ii. 10th class (SSC) certificate
- iii. MBBS & PG degree certificates
- iv. MBBS consolidated marks memo
- v. Certificate of internship
- vi. Attempt certificate of MBBS & PG (MD/MS/DNB) Degree
- vii. MBBS & PG Medical Council Registration Certificates
- viii. Study & Conduct certificates of MBBS & PG Degree. In case, the candidate studied MBBS or PG degree from state wide university / state wide educational institution shall also produce study certificate from class VI to
- ix. No objection certificate from DME, Hyderabad, (Govt. of AP/ Telangana) for permitting to pursue super speciality course, if compulsory service is not completed after PG degree course.

- x. Either of the following documents in support of non-local candidature as defined in the Presidential Order (GOP No.646, dated 10th July, 1979, A.P. Educational Institutions (Regulation of Admissions, Order 1974)
  - a) Residence certificate of the candidate for a total period of 10 years in Andhra Pradesh / Telangana excluding the period of study outside the State of Andhra Pradesh / Telangana issued by MRO/Tahsildar (applicable to those who have not studied in any institution during the whole or any part of seven consecutive academic years in Andhra Pradesh / Telangana immediately preceding the qualifying examination) OR
  - b) Residence Certificate of either of the parents for a total period of 10 years in Andhra Pradesh /Telangana excluding the period of employment outside the State of Andhra Pradesh /Telangana issued by MRO/Tahsildar as per the format prescribed in the GOP No.646 dated 10<sup>th</sup> July, 1979.
  - c) Employment certificate of the parents / spouse, if employed in the State of A.P/Telangana in the State or Central Government, Public
    Sector Corporations, Local Bodies, Universities and other similar quasi Government Institutions within the state/s, at the time of submitting the application.
- 04. The candidate who have secured a minimum of 50% marks in the entrance test are eligible to attend the counseling.
- 05. The candidate has to attend in person for counseling. No proxy/representative is permitted under any circumstances in to the counseling hall. Not attending to the counseling shall render the candidate forfeiting his/her right for admission.
- 06. No request for postponing the date of counseling or request to appear at a later or earlier date shall be entertained. In case, a candidate fails to report for counseling at the date and time specified, the seat shall be offered to the next merit candidate as per the admission rules.
- 07. The candidates are instructed to comply with all the instructions stipulated in the prospectus and other regulations of the University in force from time to time.
- 08. The counseling will be done according to the merit in each speciality. The unreserved seats shall be filled up following combined merit list of all eligible candidates and thereafter the remaining local seats shall be filled up with local candidates only.

- 10. Failure to bring and deposit the required certificates and fee shall render the candidate to forfeit the seat.
- 11. In service candidates and those who are pursuing studies at other institutions and who cannot deposit the original certificates at the time of counseling have to bring the following:
  - (i) A certificate in original signed by the Principal / Dean / University authorities mentioning the course, date of admission and the list of original certificates in their college/ University / institution.
  - (ii) The fee receipt for admission issued by the college / University authorities in original.
  - (iii) Attested photo copies of the original certificates retained in that college / University.
  - (iv) "No objection Certificate" from the parent Institution that such Institution has No Objection to the candidate's admission to undergo the post-graduate course at SVIMS and in the event of selection of the candidate to the course, he/she shall be relieved immediately.
  - (v) In case of selection of such candidate, subsequently have to submit the original certificates within one week from the date of counseling, failing which, they will forfeit the right for admission.
- 12. In all matters relating to selection and admission, the decision of the Institute shall be final and binding on the candidate and selection cannot be questioned after admissions are closed.

- 13. The selected candidate has to produce the following on the date of joining:
  - a) Medical fitness certificate certified by the Medical Officer, not lower than the rank of Civil Surgeon/ Professor working in a Government Institution,
  - b) the bond/s as per the proforma furnished in the prospectus (Appendix IV),
  - c) a copy of the PAN card.
  - d) one set of photocopy of all the certificates.
  - e) three passport size photos.
- 14. The final counseling (if any) will be notified in the website. The candidate who are absent for earlier counseling are also eligible for attend subsequent counseling. No individual communication will be sent. The candidates have to visit the website and attend for the counseling along with their certificates and fees.
- 15. Ragging is strictly prohibited. If any incident of ragging comes to the notice of the authorities, necessary action will be taken as per the institute/Govt./MCI norms.
