ORDER

In pursuance of the instructions issued by the Chief Secretary, Govt. of Haryana, General Administration Department vide No. 22/10/2013-1-GS-III dated 08.09.2016 in the CWP No. 18514 of 2016- Kalindi Vashishtha Vs. State of Haryana & others, the following candidates provisionally admitted to B.V.Sc. & A.H. programme in the College of Veterinary Sciences, Hisar for the Academic Session 2016-17 under EBP GC category vide admission order No. 1 circulated through Endst No. Reg./A-1/2016/5025-28 dated 19.09.2016 were clearly made aware about the directions of Hon'ble High Court of Punjab and Haryana, Chandigarh given in the above mentioned CWP as well as pending decision of Hon'ble Supreme Court of India in SLP (C) No. 23544-23547/2016. Now the Hon'ble Punjab and Haryana High Court, Chandigarh has ordered on 22.09.2016 in CWP Nos.18514 and 18323 of 2016 titled Kalindi Vashishtha Vs. State of Haryana and others that no admissions on the basis of notification/instructions issued for providing reservation to Economically Backward Persons in General Category shall be made for the session in question and onwards. Even the candidates who have already been admitted on the basis of reservation for Economically Backward Persons in General Category in pursuance to the order passed by this Court on 08.09.2016 will not be entitled to the benefit thereof, as even the process of admission is still in progress and classes have not yet commenced. While permitting admissions on the basis of impugned reservation policy on 08.09.2016, this Court had specifically directed that they be informed of the orders passed by this Court. The University shall be permitted to carry out fresh counseling, if required.
