ADMISSION NOTICE

It is for information of all the aspirants interested in seeking admission to B.V.Sc. & A.H. programme at College of Vety. Sciences (COVS), LUVAS, Hisar and International Institute of Veterinary Education and Research (IIVER), Bahu Akbarpur, Rohtak that **admission in these institutes for the Academic Year 2016-17 will be made on the basis of marks obtained in All India Pre Veterinary Test (AIPVT) – 2016 to be conducted by Veterinary Council of India (VCI) on 14.05.2016.** Veterinary Council of India has already announced admission notice in various newspapers. The candidates who want to seek admission in the above colleges/institutes are advised to apply for the AIPVT-2016 online on VCI website www.aipvt.vci.nic.in, www.vci.nic.in. As per VCI notification the submission of online application has commenced from 08.01.2016. The last date for online submission of application is 07.02.2016 (without late fee) and 01.03.2016 (with late fee). The detailed information is available in the **Information Bulletin of VCI** on the above mentioned websites.

Admission on all the seats in COVS, Hisar and state quota seats in IIVER, Bahu Akbarpur, Rohtak will be made as per the State Merit List to be prepared on the basis of marks obtained by the candidates in AIPVT-2016. However, admission against management quota seats in IIVER, Bahu Akbarpur, Rohtak will be made as per the All India Merit List of AIPVT-2016 for which the candidates from all over India (irrespective of Haryana Domicile) are eligible to apply for AIPVT-2016, subject to fulfillment of eligibility conditions. **The candidates interested in seeking admission to B.V.Sc. & A.H. programme in COVS, LUVAS as well as IIVER, Bahu Akbarpur, Rohtak will also be required to apply additionally through online for which the application form and the Prospectus consisting of other details will be available on the LUVAS website www.luvass.edu.in after 5th March, 2016.** However, gist of rules and regulations governing admission in B.V.Sc. & A.H. programme for academic year 2016-17 in COVS, Hisar and IIVER, Bahu Akbarpur, Rohtak is available on the university website. **The candidates who do not apply additionally for online admission on the LUVAS website will not be considered for admission even if they stand high in the merit of AIPVT-2016.**

Gist of Rules and regulations governing admission in B.V.Sc. & A.H. programme for academic year 2016-17 in COVS, Hisar and IIVER, Bahu Akbarpur, Rohtak

1. Admissions will be made on the basis of result of AIPVT-2016 to be conducted by VCI.
2. The candidates under all categories (**except SC category only**) must have passed 10+2 in each of the subjects of English, Physics, Chemistry and Biology and obtained 50% marks in aggregate of these subjects from a "recognized*/approved Board of School Education having equivalence by Council of Boards of School Education, New Delhi/CBSE/ICSE and also by Board of School Education Haryana, Bhiwani". **As per Chief Secretary to Govt. of Haryana letter no. 22/129/2013-1GSIII dated 16.07.2014, the SC category candidates will be allowed a relaxation up to 5% of the requirement for General Category i.e. the SC candidates securing 47.5% marks in aggregate of the four subjects mentioned above will be eligible to apply for admission.**
3. The candidate must have attained or will attain the age of 17 years as on 31st December, 2016. Candidates attaining 17 years on 1st January 2017 or later will not be eligible. The upper age limit for candidates of all categories (**except SC and BC**) is 25 years as on 31st December, 2016. This upper age limit shall be relaxed by a period of 5 years for the candidates of SC and BC categories.
4. The admission capacity is as below :

A. At College of Veterinary Sciences, LUVAS, Hisar

Distribution of seats for admission against the seats to be filled in with the candidates having Haryana Resident Certificate will be according to the reservation policy of admission in Government/Government aided Educational/ Technical/ Professional institutions as per detail given below :

B. At IIVER, Bahu Akbarpur, Rohtak

The admissions at IIVER, Bahu Akbarpur, Rohtak for the year 2016-17 will be subject to:

- (i) Permission of Veterinary Council of India for admission for 2016-17.*
- (ii) Grant of temporary affiliation for the year 2016-17 by the competent authority of the university.*

The admission to B.V.Sc. & A.H. programme at International Institute of Veterinary Education & Research (IIVER), Bahu Akbarpur, Rohtak shall be as per approval by the VCI and based on merit list of the Entrance Test to be conducted by VCI (AIPVT-2016).

1. A total number of 60 seats have been allotted to the institute as per details given below:

(i) State quota Seats (50%)	30
(ii) Management quota Seats (50%) including 15% NRI Seats	30

Note : The seats remaining vacant under any of the quota (State or Management) are non-transferable.

2. Distribution of seats for admission under state quota to be filled in with the candidates having Haryana Resident Certificate will be according to the reservation policy of the Haryana Government as per detail given below :

i) Scheduled Castes	20%	(06 seats)
ii) Backward Classes (A)	16%	(04 seats)
iii) Backward Classes (B)	11%	(03 seats)
iv) Economically Backward Persons in General Category	10%	(03 seats)
v) Persons with disability (PwD)	03%	(NIL)
vi) General Category of Haryana residents		(14 seats)

NOTE :

- 1. Admission on all the seats of COVS, LUVAS, Hisar and the State Quota Seats of IIVER, Bahu Akbarpur, Rohtak is available for the Haryana Domocile Candidates only. However, for admission to the Management quota seats at IIVER, Bahu Akbarpur, Rohtak, the candidates from all over India (irrespective of Haryana Domocile) will be eligible subject to fullfilment of eligibility conditions.**
- 2. The candidates interested in seeking admission to B.V.Sc. & A.H. programme of COVS, LUVAS as well as IIVER, Bahu Akbarpur will also be required to apply additionally for which the online application form will be available on the LUVAS website www.luvas.edu.in after 5th March, 2016, otherwise they will not be considered for admission even if they stand high in the merit of AIPVT-2016.**
- 3. There will be no entrance test (AIPVT-2016) for NRI candidates and Foreign Nationals seeking admission in the COVS, LUVAS and IIVER, Bahu Akbarpu, Rohtak.**
