It may kindly be ensured that before admitting the candidates, the final eligibility of each candidate must be checked/ verified strictly as per the provisions IV.(A) 1 to 4 at pages 13-15 of the prospectus and the discrepancies so pointed out by the counselling committee during the course of counseling should have also been got settled.
