MBA: International Business MBA (IB) (Session 2016)

International Centre for Cross-Cultural Research and Human Resource Management (ICccR & HRM) announces admission to the **two year full-time MBA: International Business (MBA-IB) Programme (In-take: 30 Seats)**. The candidates who are desirous of seeking admission to the course and have appeared in CAT-2015 / AIMA-MAT (May 2015/September 2015) or are appearing in AIMA-MAT (December 2015/February 2016), are required to apply separately.

Eligibility: The prospective candidate must hold a Bachelor's Degree (10+2+3 pattern), with at least 50% marks or equivalent CGPA in any discipline from a recognized Indian University or any other equivalent examination with 50% marks. The candidates who have appeared or are appearing in the final year of qualifying examination in 2015/2016, as the case may be, can also apply provisionally. However, such candidates shall have to produce the proof of having appeared and / or passed their Bachelor's Degree Examination with the requisite percentage of marks by the date as may be specified by the University of Jammu.

Application Form: The Application Forms are available in the Office of ICccR & HRM on all working days between 10.00 a.m. to 5 p.m. against a Bank Draft of Rs. 500/- drawn in favour of Director, ICccR & HRM, University of Jammu, payable at Jammu. The prospective candidates may choose to download the Application Form from the Website: www.jammuuniversity.in. Such application/s must be accompanied by Bank Draft as per above. The last date of submission of Application Form complete in all respects, by hand or by post is March 04, 2016.

NOTE: As per MBA-IB Statutes, admission in the first instance shall be made on the basis of valid CAT score. If seats remain vacant the same shall be filled using valid MAT score. University of Jammu uses CAT/MAT score for shortlisting the candidates for the MBA-IB programme. Further, CAT/MAT score constitute one of the parameters of selection, besides other components as per the statutes and norms of University of Jammu.
