All the eligible ST/SC/OBC/SEBC students studying at Post-Matriculation or Post-Secondary stages are hereby informed that the online submission of duly filled-in PMS applications in PRERANA Portal for Post Matric Scholarship and Financial Assistance to Students studying in National Level Institutes, its scrutiny, and processing is scheduled to be held as per the date line indicated below.

Post Matric Scholarship Scheme-

Eligibility-

- (1) ST/SC students who are continuing their Post Matriculation Studies in any general/technical or professional courses in any Govt. or Govt. recognized Private institutes, and the annual family income of the parent/guardians from all sources of those ST/SC students is not exceeding Rs. 2.50,000/- per annum.
 - annual family income of the parent/guardians from all sources in case of OBC/SEBC students should not exceed Rs. 1,00,000/- per annum and they have to secure at least 50% marks in previous examination.
- (3) He/She should be permanent resident of Odisha.

Finacial Assistance Scheme for ST students only to study in all National Level Institutes-

- (1) ST students who are continuing their Post Matriculation Studies in any National level Institute and the annual income of the parent/guardian of Eligibilitythose ST students is not exceeding Rs. 2.50,000/- per annum.
- (2) He/ She should be permanent resident of Odisha.
- (2) The cost of Course Fee and Maintenance Fees of these students in first instance have to be charged to Post Matric Scholarship Scheme and the excess amount exceeding the maximum limit shall be sanctioned out of Financial Assistance Scheme.

Eligible students are advised to fill up their applications through ONLINE mode by accessing http://ori.nic.in/odishapms. and obtain a print-out of the duly filled in application forms and submit the same along with all supporting documents to the concerned Institutes, where they are studying, for further processing,
