NOTICE FOR ADMISSION IN M.PHIL AND PH.D. PROGRAMMES (2016-17)

It is hereby notified for all concerned that applications are invited, in the prescribed form, for admission in M. Phil. & Ph.D programmes of West Bengal State University (WBSU) for the academic session 2016-17. The eligibility of the candidates will be guided by clauses & sub-clauses under "Regulations for the Degree of Master of Philosophy (MPhil) /Doctor of Philosophy (Ph.D) ,April 2013 of West Bengal State University" (Ref: WBSU/Reg/Notice/Regulations (MPhil-PhD)/1061/13 dated 05.04.2013) along with its amendments (Ref: WBSU/Reg/PhD/1516/13 dated 29.08.2013)

The candidates may download the Application Form from the University website. <u>Downloaded Form is to be submitted along with the application fee of Rs 1000/-(Rupees 500/- for SC/ST candidates) either in cash or in the form of demand draft to the University Counter from 11 am to 3 pm on any date from 01st <u>September 2016 to 12th September 2016 (except on Saturdays and Sundays and also on University Holidays)</u>. Candidates who want to submit the application fee in the form of draft must note that it should be payable in favour "West Bengal State University".</u>

N.B.: Persons with disabilities will enjoy a 3% reservation in each categories i.c. SC, ST, OBC (A), OBC(B) and in the unreserved General Category and such candidate, if available, shall be placed towards top of the list prepared for each category of students in terms of letter bearing number 65-Edn(U)/1U-89/13 dated 16.01.2014 issued by Higher Education Department, Government of West Bengal.

Candidates in the general category will have to secure at least 55% and candidates in the reserved category (SC/ST/OBC (A)/OBC (B)) will have to secure at least 50% at the Master's level to be eligible for admission in this programme.

Candidates who have applied for PhD programme of WBSU earlier but their applications are not processed for admission in the above-mentioned programme by various academic departments of the University need not apply this time. Their applications will be considered this time as cases of backlog candidates.

The University shall conduct a Common Admission Test (CAT)[Referred to as Research Entrance Test(RET)] for the MPhil-Ph.D. programme after issuing appropriate notification. The Admission Test will consist of two parts: a written test of 200 marks with two parts. The First Part will be compulsory for all students consisting of 100 marks (50 Multiple Choice Objective Questions of two marks each) which will be based on general knowledge, logical reasoning, basic arithmetic and/or English etc. The Second Part will be the subject paper of 100 marks (50 Multiple Choice Objective Questions of two marks each in the subject concerned). Apart from the usual candidates, the backlog candidates will also have to appear in RET.

Candidates who will qualify in the admission test will have to face an interview of 50 marks (assessing the grasp over the subject, aptitude for current issues in the subject concerned, general personality, academic organizational and analytical ability, readings in the area of specialization).

A candidate will qualify for the interview only if she/he scores 50% or more in the written examination (both compulsory and subject paper).

The list of eligible candidates for Research Entrance Test (RET) shall be displayed in the university website and the Schedule of test shall also be notified. The date of collection of admit card for appearance in the RET will also be notified in the University website. Candidates with NET/SET/GATE/M.Phil qualifications will be exempted from the RET(Written part). However, they will have to appear in interview.

Course work can be waived for candidates (after showing relevant proof) who are unable to complete their PhD but have successfully completed PhD course work from any University or recognized institute. However, RET (written part) will not be waived for them and they will have to appear both in RET(written part) and interview.

The list of successful candidates eligible for admission in MPhil/PhD programme will be notified in the University website in due time after interview. The backlog candidates who will be eligible for admission may be asked to submit self-attested copies of relevant documents at the time of admission.

Fee for Indian Nationals at the time of Admission:

- 1. The list of selected candidates will have to deposit a fee of Rs 4500/- (Rupees Four Thousand Five Hundred only) at the time of admission in MPhil/PhD programme of the University. This is also true for the backlog candidates. It is to be noted that this fee is the Course Fee for PhD and also the Course Fee for the First Semester of MPhil. [The candidates who will be admitted for MPhil programme will have to submit the Second Semester MPhil Fee at the beginning of Second Semester Course Work and not at the time of the Admission in the MPhil Programme. Apart from this the MPhil and PhD candidates will have to submit the Registration Fee and Thesis Submission Fee later in due time]
- 2. PhD Course work can be waived for candidates having MPhil degree from any recognized institute or University It can also be waived for candidates who have successfully completed PhD course work from any University or recognized institute. These candidates will have to show proof of completion of their PhD Course work. The Convener of the Board of Research Studies will have to forward the appeal of the candidate for waiver of Course Work to the Vice Chancellor. The final decision regarding waiver of course work will be taken by the Vice Chancellor. However, it is to be noted that waiver from Course work means direct eligibility for PhD registration, it does not mean waiver of Course work fee for PhD programme. So all these candidates will have to pay Course Fee of Rs 4500/-(Rupees Four Thousand Five Hundred only) at the time of admission. In no case waiver of such fee will be entertained by the University authority.

Fcc for Foreign Candidates (SAARC Countries) at the time of Admission:

1. The list of selected candidates will have to deposit a fee of Rs 5625/-(Rupees Five Thousand Six Hundred Twenty Five only) at the time of admission in MPhil/PhD programme of the University. This is also true for the backlog candidates. It is to be noted that this fee is the Course Fee for PhD and also the Course Fee for the First Semester of MPhil.[The candidates who will be admitted for MPhil programme will have to submit the Second Semester MPhil Fee at the beginning of Second Semester Course Work and not at the time of the Admission in the MPhil Programme. Apart from this the MPhil and PhD candidates will have to submit the Registration Fee and Thesis Submission Fee later in due time]

2. PhD Course work can be waived for candidates having MPhil degree from any recognized institute or University It can also be waived for candidates who have successfully completed PhD course work from any University or recognized institute. These candidates will have to show proof of completion of their PhD Course work. The Convener of the Board of Research Studies will have to forward the appeal of the candidate for waiver of Course Work to the Vice Chancellor. The final decision regarding waiver of course work will be taken by the Vice Chancellor. However, it is to be noted that waiver from Course work means direct eligibility for PhD registration, it does not mean waiver of Course work fee for PhD programme. So all these candidates will have to pay Course Fee of Rs 5625/-(Rupees FiveThousand Six Hundred Twenty Five only) at the time of admission. In no case waiver of such fee will be entertained by the University authority.

Fee for Foreign Candidates (Non-SAARC Countries) at the time of Admission:

- 1. The list of selected candidates will have to deposit a fee of Rs 6750/- (Rupees Six Thousand Seven Hundred Fifty only) at the time of admission in MPhil/PhD programme of the University. This is also true for the backlog candidates. It is to be noted that this fee is the Course Fee for PhD and also the Course Fee for the First Semester of MPhil.[The candidates who will be admitted for MPhil programme will have to submit the Second Semester MPhil Fee at the beginning of Second Semester Course Work and not at the time of the Admission in the MPhil Programme. Apart from this the MPhil and PhD candidates will have to submit the Registration Fee and Thesis Submission Fee later in due time]
- 2. PhD Course work can be waived for candidates having MPhil degree from any recognized institute or University It can also be waived for candidates who have successfully completed PhD course work from any University or recognized institute. These candidates will have to show proof of completion of their PhD Course work. The Convener of the Board of Research Studies will have to forward the appeal of the candidate for waiver of Course Work to the Vice Chancellor. The final decision regarding waiver of course work will be taken by the Vice Chancellor. However, it is to be noted that waiver from Course work means direct eligibility for PhD registration, it does not mean waiver of Course work fee for PhD programme. So all these candidates will have to pay Course Fee of Rs 6750/- (Rupees SixThousand Seven Hundred Fifty only) at the time of admission. In no case waiver of such fee will be entertained by the University authority.
